## MAGIC 1061 MAGIC FOR A YEAR 2.0 RULES

MAGIC 1061 MAGIC FOR A YEAR 2.0 CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- **1. ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario; and.
  - (b) be of the age of majority or older at the time of entry.

## 3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - (i) Listen to the Station Monday to Friday during the Contest Period (excluding statutory holidays) at approximately 8:10 a.m., 12:10 p.m., and 4:10 p.m. ET for the Contest question of the day (the "Question"). Upon hearing the Question, listeners are invited to visit <a href="https://magic106.com/">https://magic106.com/</a> (the "Contest Website") to complete and submit the entry form including the correct answer to the Question to enter the prize draw.
- (b) Limit of one (1) entry per Question during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- (c) All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. ## 6. WINNER SELECTION.

- (a) Every Friday during the Contest Period starting on September 17, 2021 and ending on October 15, 2021 in Guelph, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received by 11:59 p.m. ET on the Thursday immediately preceding the draw date. Entries do not rollover to subsequent draws. Each entrant shall be eligible to win only one (1) Prize. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
