# MAGIC 106 GUELPH "WIN IT ALL" RULES

THE WIN IT ALL CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR IN PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

- **1. ELIGIBILITY.** To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario; and
  - (b) be of the age of majority or older at the time of entry.

Employees of Corus Radio Inc. operating CIMJ-FM (the "Station") and its parents, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "Corus"), River Run Centre; owned and operated by the Corporation of the City of Guelph, The Guelph Storm, Sleeman Centre and their affiliates, subsidiaries, related companies, successors and assigns (together with Corus, the "Sponsors"), advertising and promotional agencies and/or the household members of any of the above are not eligible to enter.

The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply untruthful, incomplete, inaccurate, or misleading personal details and/or information.

2. CONTEST PERIOD. The Contest begins at 6:40 a.m. Eastern Time ("ET") on October 3, 2022 and ends at 4:40 p.m. ET on November 4, 2022 (the "Contest Period") after which time the Contest will be closed and no other entries shall be accepted.

## 3. HOW TO ENTER.

- (a) There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
  - (i) Listen to the Station Monday to Friday (except on October 10, 2022) during the Contest Period between 6:40 a.m. and 4:40 p.m. ET for the cue to call (the "Cue to Call"). CUE TO CALL WILL AIR AT 6:40 am, 7:40 am, 8:40 am, 9:40 am, 2:40 pm and 4:40 pm weekdays. Upon hearing the Cue to Call, listeners are invited to call into the Station at 519-836-1061 (the "Contest Line"). The sixth (6<sup>th</sup>) caller through the Contest Line will qualify to enter the prize draw (each a "Qualifier").

There will be six (6) Cues to Call daily (on weekdays minus statutory holidays) at times mentioned above.

(b) Only one (1) entry per Qualifier per household to the Prize draw is permitted during the

Contest Period. Once an entrant has been chosen as a Qualifier, entrants will no longer be eligible to enter the Contest for the remainder of the Contest Period. Multiple entries will be discarded.

- (c) All entries, become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- (d) Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Call. Sponsors assume no liability for entrants not making timely phone calls to the Station due to delays in the streamed signal.
- (e) If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined below) will not be liable in any way.

### 4. PRIZE.

- (a) **Prize.** There is one (1) prize ("**Prize**") available to be won by the Prize winner ("**Winner**") consisting of:
  - (i) Two (2) tickets to see every RIVER RUN CENTRE PRESENTS event held between November 5, 2022 to April 28, 2023 at the RIVER RUN CENTRE (35 Woolwich Street, Guelph, Ontario); and
  - (ii) Two (2) tickets to every single Guelph Storm home game held at the Sleeman Centre (50 Woolwich Street, Guelph, Ontario) during their regular season (November 5, 2022 through March 23, 2023).
    - PLEASE NOTE: Tickets include all River Run Centre Presents Concerts only, plus Guelph Storm home hockey games. Tickets do NOT include: private functions, civic functions, not for profit events, rentals, third party events or tours
- (b) The Prize has an approximate value of Five Thousand Five Hundred and Fifty Canadian dollars (CDN \$5,550.00).
- (c) Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- (d) The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within twenty (20) days once such Winner has been successfully contacted and notified of his/her Prize and fulfilled the requirements set out herein.

# 5. PRIZE CONDITIONS.

- (a) Winner will be responsible for all incidental costs and expenses not explicitly included in the Prize.
- (b) One pair of tickets (unless otherwise stated), seats are non-transferrable, seat numbers may change by show/game, or may need to be moved to another section subject to show/game's ticket sales
- (c) The terms by which the tickets may be redeemed are governed by RIVER RUN CENTRE and GUELPH STORM. Corus is not responsible for administering or ensuring compliance with the terms and conditions relating to the River Run Centre or Guelph Storm home game tickets.
- (d) Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prize (or any portion thereof) cannot be awarded for any reason.

## 6. WINNER SELECTION.

One (1) Winner shall be selected as follows:

- (a) On or about Friday, November 4, 2022 in London, Ontario, one (1) Qualifier will be selected by a random draw from all eligible entries received during the Contest Period. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail, to comply with the Contest Rules and sign and return the Release (described below).
- The odds of being selected as a potential winner are dependent upon the total number of people who call the Contest Line during a Cue to Call. Once selected as a Qualifier, the odds of being selected as a potential Prize winner are one (1) in one hundred and fourty four (144).
- (c) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN NOVEMBER 4, 2022 AT 5:00 PM ET AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, he/she will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there

will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

- 7. RELEASE. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including those reasons beyond the control of the Sponsors, such as tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest.
